Summary

By the end of this year, the film will have been shown on **472 occasions in 39 countries** in cinemas, at special arranged screenings or at film festivals. **97 seminars, discussion and panels** have taken place around these screenings.

The film has been **screened on TV in 9 countries** and has been seen by millions of viewers. The film has made substantial impact in social media with a reported **reach of 7 million on Facebook, Instagram, Twitter, Youtube and blogs** and an **editorial reach of 37 million with 126 published articles.**



Major issues:

Corruption. Deforestation. Illegal logging. Indigenous land rights. Impacts of dams. Press Freedom.

Challenges: Old News? Borneo is a known place but one that is associated with historical environmental abuses in the eyes of many. Either it's "too late" or "old news". Our goal is to re-establish this as a pressing issue in people's minds.

Impact Objectives:

1. To create Greater Public Awareness in Europe and US. Re-enliven debate around Borneo and extractive industries.
2. Support and sustain the work of the campaigners in the film.
To use the film to bring attention, new connections and fundraising opportunities to support the work of the Global Bersih, Save Rivers, Bruno Manser Fund, Radio Free Sarawak and others.
3. Achieve greater press and public awareness in Malaysia itself.



We are very happy to give you a rundown of the fantastic journey the Borneo Case has done since the premiere in **Kuala Lumpur** in August 2016.

At the end of the year, the film will have been shown on **472 occasions in 39 countries** in cinema, at special shows and at festivals. The main characters in the film, the filmmakers and representatives from Borneo has participated in **97 seminars, discussions and panels** in connection with the screenings. The film has been screened on TV in **9 countries** and has been viewed by millions. Many more countries will follow in TV deals that we are concluding at the moment. Among them is Al Jazeera international, with a scheduled screening to coincide with the upcoming election in Malaysia.

Particularly important, is the close collaboration with **Global Bersih**, the Malaysian civil rights movement. With the premiere in Kuala Lumpur, we established an important collaboration with Malaysian partners, which led, among other things, to the film being shown in **30 cities from Busan in South Korea to Los Angeles, USA**, on the Malaysian National Day, **September 16, 2017**.

We have collaborated with a number of other organisations that used the film as a focus point in the debate on human rights issues, the situation of indigenous peoples, democracy, environment and climate issues and the threat to the world's remaining rain forests. A focus point intimately linked to The Borneo Case is the palm oil question that becomes more important for each day.

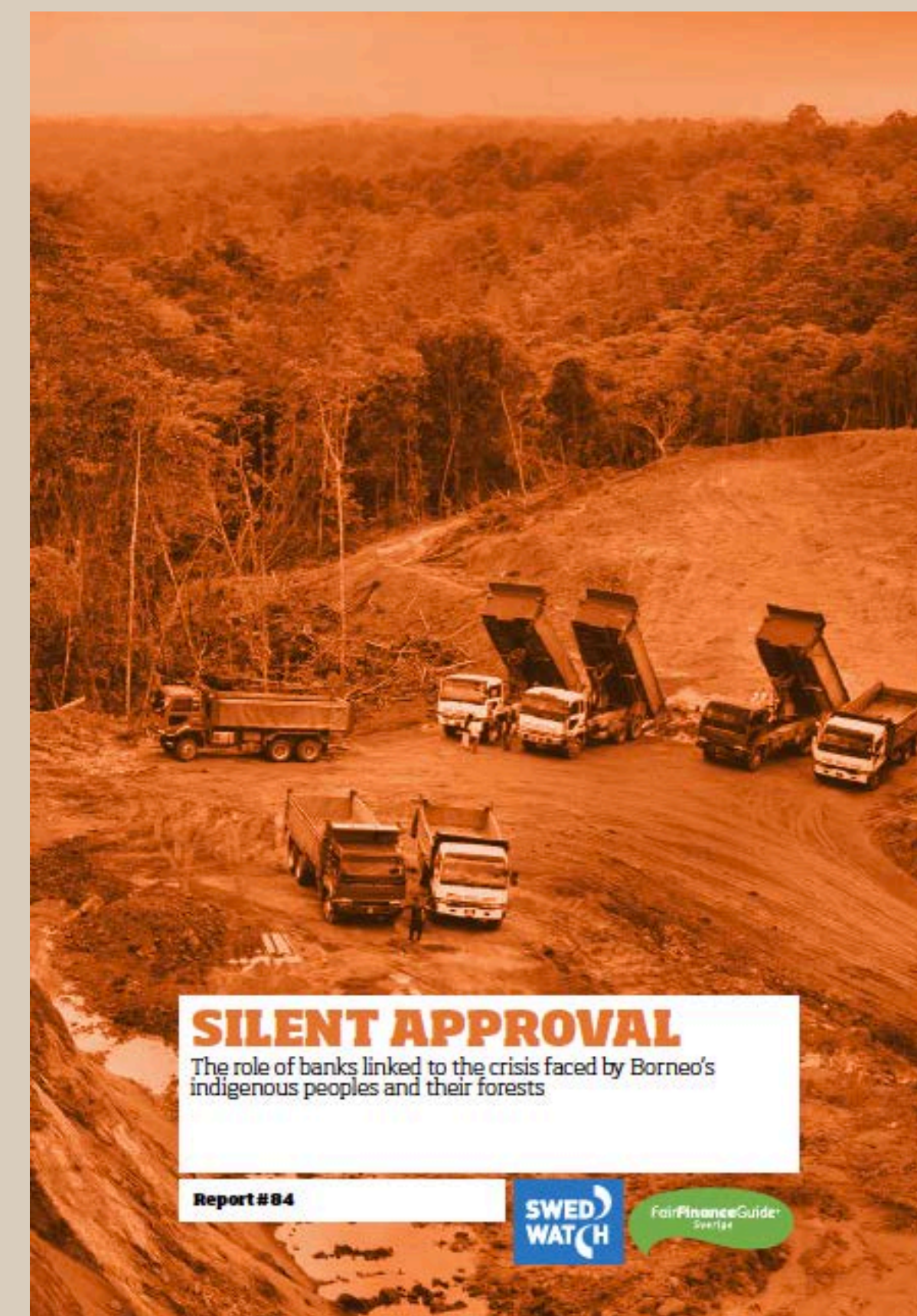

SILENT APPROVAL

In Sweden we have collaborated with the Fair Finance Guide, an NGO represented in nine countries, Swedwatch and the Swedish Society for Nature Conservation to release the 112-sided report "Silent Approval" in connection with the premiere of the film in March.

It shows how **Sweden's 7 largest banks** all share in the **environmental destruction and expulsion of indigenous peoples** who are taking place on Borneo. Mutang Urud and Clare Rewcastle made a weeklong visit to Sweden in connection with the premiere. The campaign we conducted together with the Fair Finance guide around the report has had a big impact in the media. A first page in Dagens Nyheter, Sweden's biggest newspaper was followed by a lot of articles that included the report and the film. The report and the film was featured in radio and television in Sweden and internationally.

The report "Silent Approval" has made substantial impact in social media with a reported reach of 1.4 million on Facebook, Instagram, Twitter, Youtube and blogs and an editorial reach of over 83 million with 81 published articles. (For details see attached Media Report)

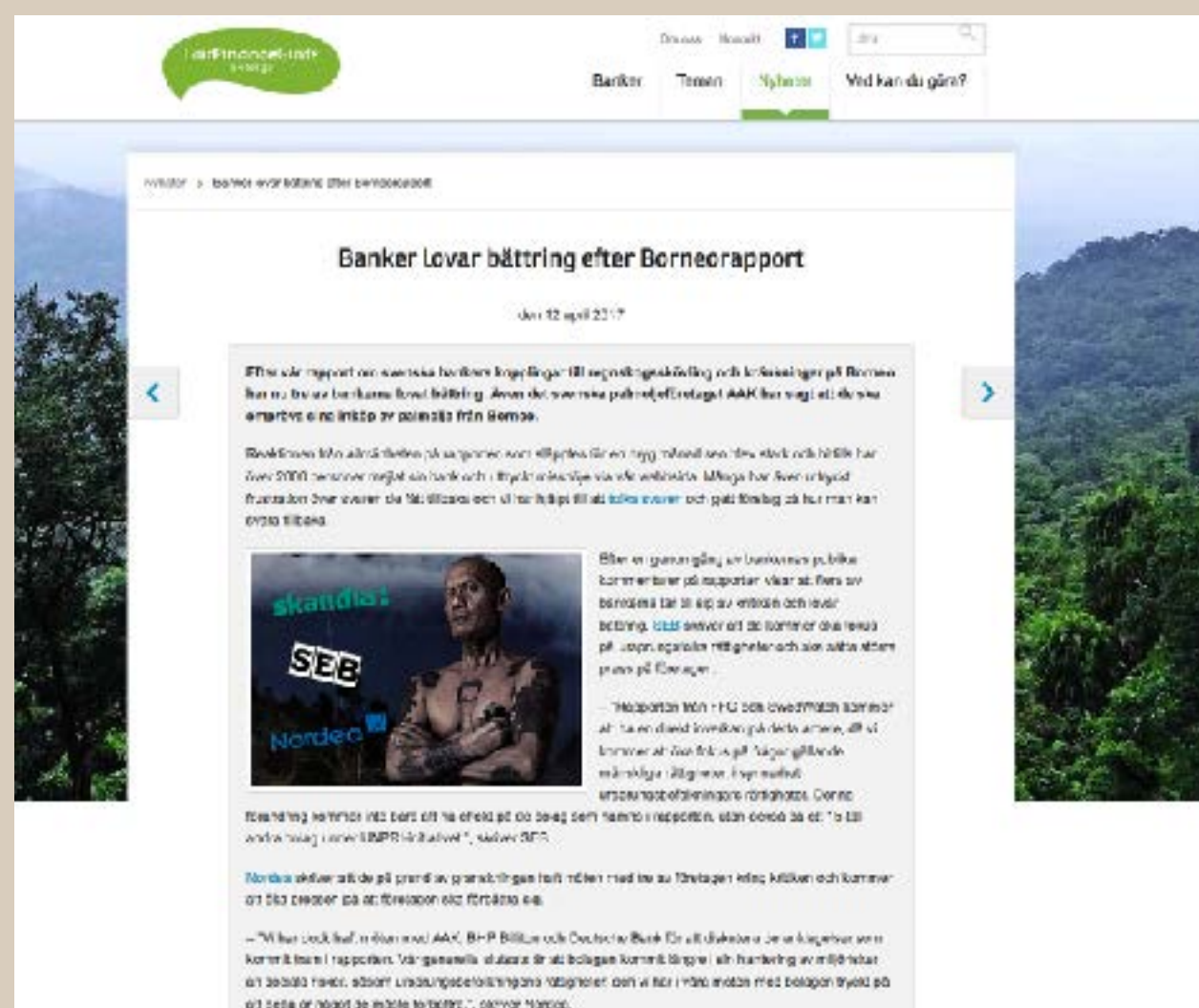




An important part of the Swedish campaign has been that customers should contact their bank in order for the bank to change the behaviour. Several of the banks surveyed in the Fair Finance Guides report have announced that they are reviewing their investments.

One example is Nordea where Sasja Beslik, Head of Sustainable Finance, Nordea Wealth Management, writes, "**We have had meetings with AAK, BHP Billiton and Deutsche Bank to discuss the allegations made in the report and we have stressed that this is something they need to improve.**"

In Norway, we have worked with, among other things, Fritt ord, FIVAS, the Future in our Hands, the Norwegian Fair Finance Guide and Aftenposten to give the film as much attention as possible. In conjunction with the premiere Fair Finance Guide Norway, supported by the Consumer Council and the Future in our Hands, released a similar report on the involvement and ownership of Norwegian banks involvement in the expulsion of indigenous peoples and environmental degradation in Borneo. **NRK produced a 1-hour Urix special**, their main current affairs program, around the film, the report and Clare Rewcastle and Mutang Uruds work. The viewing figures for the film that followed the Urix special at NRK were unusually high.

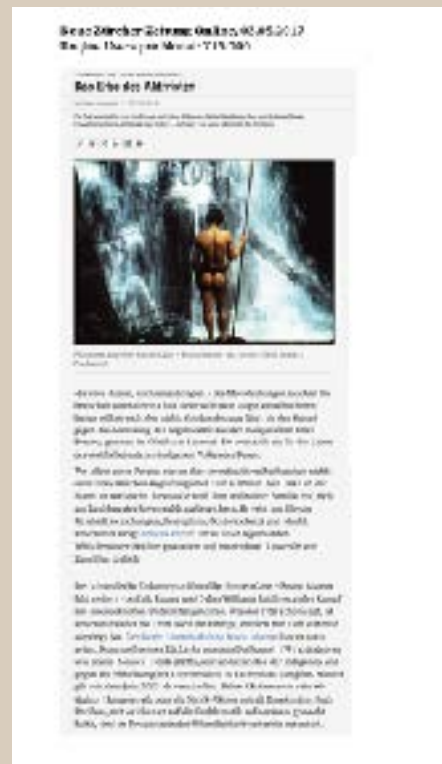
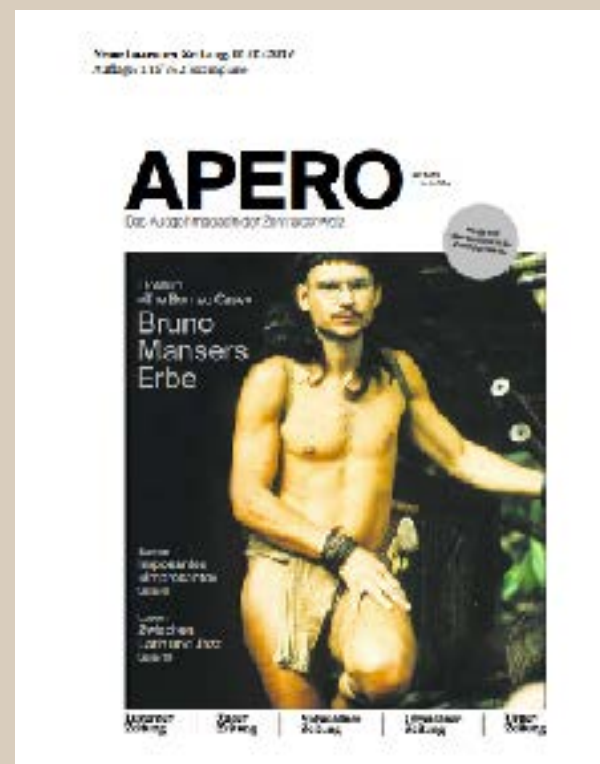


In Germany we have and on-going in collaboration with Fair Finance Guide Germany in order to produce a report on German banks that will be released in connection with a **special release of the film at ZDF Arte.**

Another important partner is the Swiss **Bruno Manser Fonds**, (BMF) who has headed the impact campaign in Switzerland. In conjunction with the premiere of the film, 8 special events were organized where representatives from the indigenous people participated together with the film's main characters and the authors of the film. During the spring the film has been shown on cinema in **23 Swiss cities**.

In August Bruno Manser Fond **sued** Saktu, a company allegedly owned by the former chief minister of Sarawak and his family at the **Supreme Court of Ontario Canada**. The objective is to prove the money laundering that made it possible to build up the Taib family's Real Estate Empire in North America with money stolen from illegal logging. In connection with the trial, a delegation of Borneo Penans will visit Canada together with Lukas Straumann and Mutang Urud.

A series of different events and screenings of the film will take place during the trial. We are also planning a show in Brussels in the spring of 2018 for EU delegates, decision makers and NGOs dealing with the issues raised in the film.

The film was in December in collaboration with Dutch **Movies That Matter** screened in **Dutch embassies in 14 countries around the world**. In connection with these screenings, seminars and activities was organised.

Movies That Matter is a festival and organisation that uses documentaries with the aim to bring together governmental organisations, banks, financial institutions, top-level politicians, decision-makers and NGOs to discuss social issues and influence development in a sustainable direction. The Borneo Case participated in the main festival held in March in The Hague. Mutang Urud and Erik Pauser were in place representing the film. In addition to a series of screenings, formal and informal meetings and conversations were held with, among others, Mary Robinson, former Prime Minister of Ireland and EU politicians who have now started the Climate Justice Foundation In addition, meetings were held with the chairman of Amnesty International Holland, ASN bank and others. Several TV channels sent reports and interviews.



Another important cooperation has been with **Transparency International**. The film was shown at the **IACC International Anti-Corruption Summit in Panama**, where Clare Rewcastle, Lukas Straumann and Erik Pauser participated. In cooperation with Transparency International and **Cinema For Peace**, the film was screened in Hamburg in connection with the **international G20 meeting**. A discussion with Dylan Williams followed the screening.

A teacher's guide and a school material of 48 pages adapted to the Swedish Upper Secondary School's curriculum for social sciences, geography, Swedish and economics were released in November and have in this short time been downloaded by over 100 teachers.

The Teacher's Guide has also been **translated into English** to be used by Collective Eye, an American teacher's distributor. **A German translation** is under way. As part of a university **tour around Green Finance**, screenings and seminars have been held at the Stockholm School of Economics, Luleå University of Technology, Malmö University, and in cooperation with Uppsala University. An interview film with Jakob König Project Manager at the Fair Finance Guide has been produced to be used in various ways in this work. Together with the Swedish Nature Conservation Association another important partner, we have made a Swedish tour with the film.





The Impact campaign has been made possible with the help and generous support from; The Swedish Postcode Foundation, Bertha Foundation, Britdoc, Swedish Film Institute, Transparency International, Movies That Matter, Bruno Manser Fond, Fritt Ord, FIVAS, Framtiden i våre hender, Fair Finance Guide, Swedwatch, The Swedish Nature Conservation Association, Forbrukerrådet, Influence Film foundation, World View, 11th hour project, and KOMAS. Countless private persons has also supported the campaign with their work.



In the coming year, we will continue to spread the film in the world through the network of partners we have established. The film will be screened on Al Jazeera International in the spring. At the same time, elections will be held in Malaysia. Through our on-going impact campaign, we will try to put the issues raised by the film on the agenda. Various events and media work will be carried out in connection with the release of the Fair Finance Guide Germany's report linked to the film.

Overview about “The Borneo Case”

The documentary “The Borneo Case” was produced by the Swedish film makers Erik Pauser and Dylan Williams. The film deals with the illegal deforestation in Malaysia and begins with the disappearance of the Swiss environmental activist Bruno Manser in 2000. Manser had lived with the Penan tribe in the Malaysian federal state Sarawak on Borneo for six years and engaged for the rainforest preservation and for the human rights of the indigenous community. Additionally, he founded the Bruno Manser foundation. After Manser’s disappearance, other human rights activists have continued his work. The film sheds light on the current situation in Malaysia and introduces the four main protagonists to the audience – the exiled tribesman Mutang Urud, the investigative journalists Clare Rewcastle Brown and Peter John Jaban as well as the historian and executive director of the Bruno Manser fund Lukas Straumann. Since several activists have been convicted and prosecuted for expressing their opinion in Malaysia, the five characters mostly work from abroad. Much attention is paid to the Online Radio station “Sarawak Report” which was founded by Clare Rewcastle Brown in London and which has served as an international platform to broadcast information about the political and ecological situation in Sarawak since it was founded in 2010.

Presisering 1: I den første versjonen av denne artikkelen sto det at norske finansinstitusjoner har investert nær fire milliarder kroner i de fem aktuelle selskapene. NRK presiserer at rapporten til Etisk bankguide ikke kun omfatter norskeide finansinstitusjoner, men også omfatter fond eid av banker som opererer i det norske markedet, men har hovedkontor i andre nordiske land.

Presisering 2: NRK har i siste nettartikkel om saken valgt å nedjustere de norske finansinstitusjonenes investeringer i fond som har eierandeler i «Borneo-selskapene» fra 4 til 3,5 milliarder kroner. Årsaken er at FIVH i en mail til NRK sier at «4 milliarder er summen av alle beholdninger i disse selskapene i alle fond når man ansvarliggjør hver bank for hele verdien av fondenes investeringer i hvert enkelt selskap. Hvis man imidlertid teller verdien av investeringene i fondet som sparebankene distribuerer kun en gang – blir totalsummen 3,573 milliarder kroner».

Det er avsløringene i dokumentarfilmen «The Borneo Case» som har ført til at Etisk bankguide har gransket norske bankers investeringer i fem konkrete selskaper. Selskapene er valgt fordi deres virksomhet på ulike måter kan knyttes til menneskerettsbrudd, særlig brudd på urfolks rettigheter, og avskoging på Borneo.

Scandinavian banks fund Borneo rainforest abuses - campaigners

LONDON, March 7 (Thomson Reuters Foundation) - Scandinavian banks are funding industrial developments responsible for deforestation and violence in the rainforests of Borneo, despite commitments to respect the rights of indigenous forest-dwellers, a campaign group said on Tuesday.

Seven financial institutions have backed mining projects and palm oil plantations that caused rapid rainforest destruction and a human rights "crisis" on the Southeast Asian island, Swedwatch said in a report.

Frida Arounsavath, a researcher for Swedwatch, said banks were failing to ensure that companies they funded acquired meaningful consent from indigenous people before clearing forests where they live.

"These companies have breached indigenous people's rights to be consulted and their rights to keep their traditional forests," Arounsavath told the Thomson Reuters Foundation.
